#### Revised MnCHOICES Update

The new MnCHOICES Training Zone MTZ (AWS) is available as of June 1, 2023.

DHS sent MnCHOICES Mentors two important emails, which should be carefully reviewed:

- May 30<sup>th</sup>, Access to MTZ Revised MnCHOICES application new platform, for important information, including the link and password.
- May 31<sup>st</sup>, *New MTZ Launch Updates*, for instructions on how to create a new MTZ Revised MnCHOICES bookmark, and how to clear your browsing cache.

Some important takeaways to note:

- Micro-learnings have been moved to <u>Trainlink</u> under course link MNCH901.
- Data from the old MTZ has been loaded to the new MTZ for work completed through November 30, 2022.
  - This includes MTZ usernames, any assigned people and forms associated with them, and duplicate assessments to create support plans.
  - Previously, Care Coordination Delegate agencies were provided a list of usernames to log into the (old)
     MTZ training zone. These same usernames can be used to access the new MTZ training zone (AWS).
  - o Reach out to your MnCHOICES Mentor for this information.
  - If your agency has misplaced this list or your agency was new as of 1/1/2023 and your agency did not receive this list, your MnCHOICES mentor can reach out to your Partner Relations Consultant to request a copy or list of usernames.
- Any work completed in the (old) MTZ after November 30, 2022 is not included in the new MTZ (AWS). **This** includes Person, forms, new usernames, and changes to old MTZ user roles.
- Roles and permissions were updated, including offline mode.
